Terms and Conditions:

1. Payments

Payments are made in advance via Direct Debit from a nominated credit card or bank account. Charges are processed fortnightly for the approved amount as stated on your Direct Debit Request Form. If the Direct Debit coincides with a public holiday, your payment will be processed on the next business day. Your debit amount may take up to 4 weeks to appear on your bank statement.

When a payment is returned by the bank, an alternative payment must be made to Kirby Swim. This amount will remain outstanding until alternative arrangements have been made. It is the responsibility of the customer to ensure funds are available for Direct Debit at the due date.

2. Term

Lessons are held continuously throughout the year, including school holidays. Therefore payments will continue to be processed until a "Change in Enrolments" Form is completed.

3. Changes to Membership and Cancellations

All changes to levels must be advised by the On Deck Supervisor. These changes will be made on a "Change in Enrolments" Form for your records.

Cancellations must be made in writing. A Change in Enrolment Form is available at the centre. Any outstanding fees must be paid at the time of cancellation. Notification to cancel lessons must be received as per terms and conditions of cancellation.

4. Suspension

As lessons are not conducted throughout the Christmas and New Year break all enrolments will be suspended for payment over this fortnight period. If this fortnight falls on two payment periods, each payment will be prorated accordingly.

Participants are also entitled to suspend their enrolment for a further 2 week period per year for personal reasons. These suspensions are to be notified on a "Change in Enrolments" Form in advance to the requested time off. Enrolments and payments will automatically recommence after the suspension period.
